Partnership Models

We offer flexible partnership structures designed to align with your organization's goals, capacity, and mission.

Strategic Funding Partnership

Program Co-Delivery

Joint design and delivery of community programs. Partners bring resources, expertise, or volunteer capacity; we bring program structure and community connections.

Corporate Employee Engagement

Foundation & Institutional Partnership

Strategic Partner — \$25,000+

Premier partnership with deep organizational integration.

Core Partner — \$10,000-\$24,999

Community Partner — \$5,000-\$9,999

Solid support for specific initiatives or programs.

Emerging Partner — \$1,000-\$4,999

Entry-level partnership building toward deeper engagement.

- Recognition on website and social channels
- Partnership certificate

Flexibility & Modification

Partnerships can evolve. If circumstances change, we're open to conversation and adjustment — but all modifications must be documented in writing.

Termination

Either party may terminate partnership with 30 days' notice in writing. Funds paid are non-refundable, but we'll work together to ensure a smooth transition.
